

As well, the outlook now for Panama is sunny and blue skies...the IMF recently projected steady growth into 2015, and the country has been recognized as "investment grade."

The Panama Canal expansion project is close to completion...a new highway has been built between the country's two main cities, Panama and Colon...a new Metro subway system recently opened in panama City, the first of its kind in the region...and downtown in the capital is being completely reconfigured with a new, widened central thoroughfare, a city bypass system, and a broad, grassy stretch of parkland along the bay.




